**Opinion**

**Basis for Opinion**

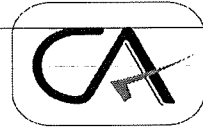

**1. SIGNIFICANT ACCOUNTING POLICIES**

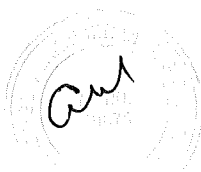
**(I.) Basis of Accounting**

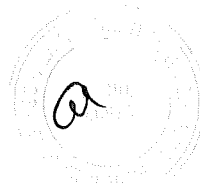




